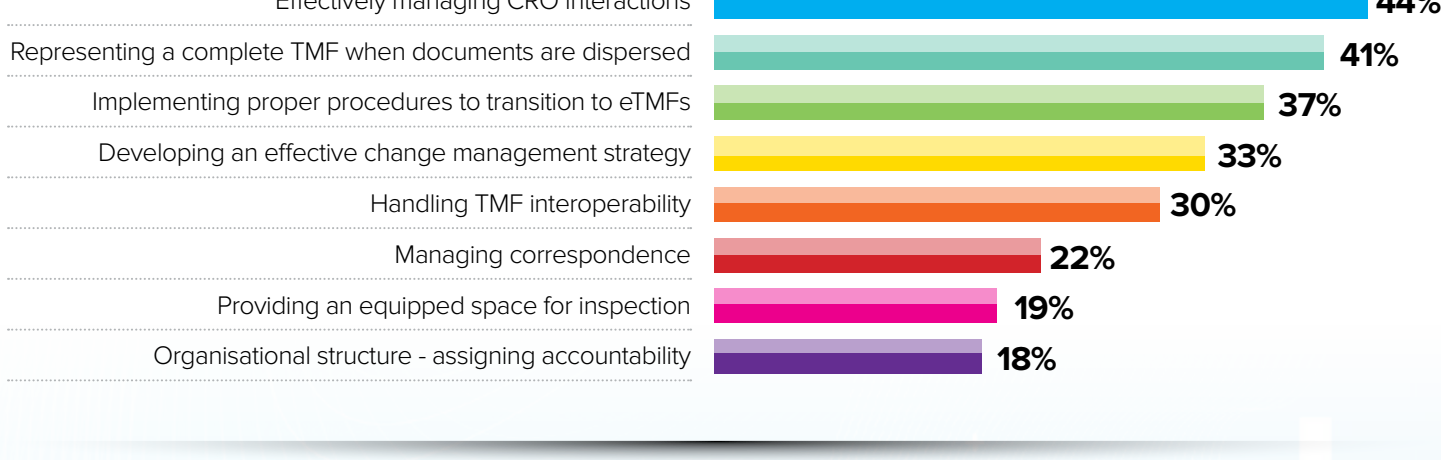


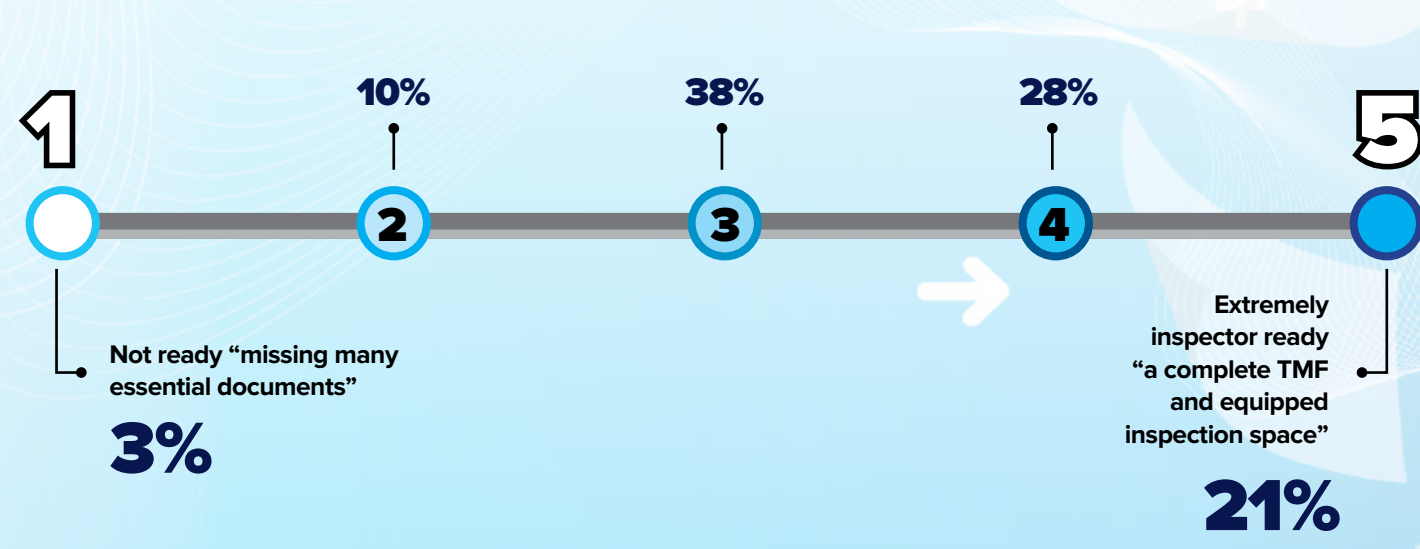
THE STATE OF TRIAL MASTER FILES: 2015 SURVEY RESULTS

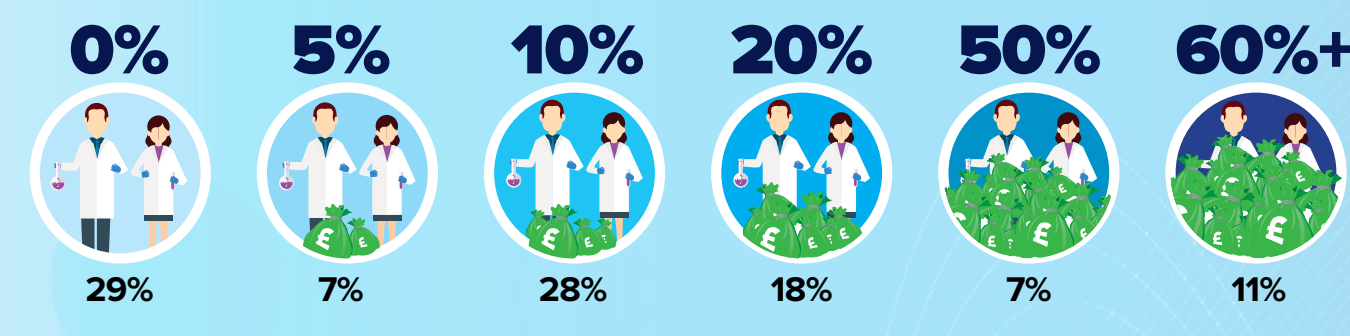

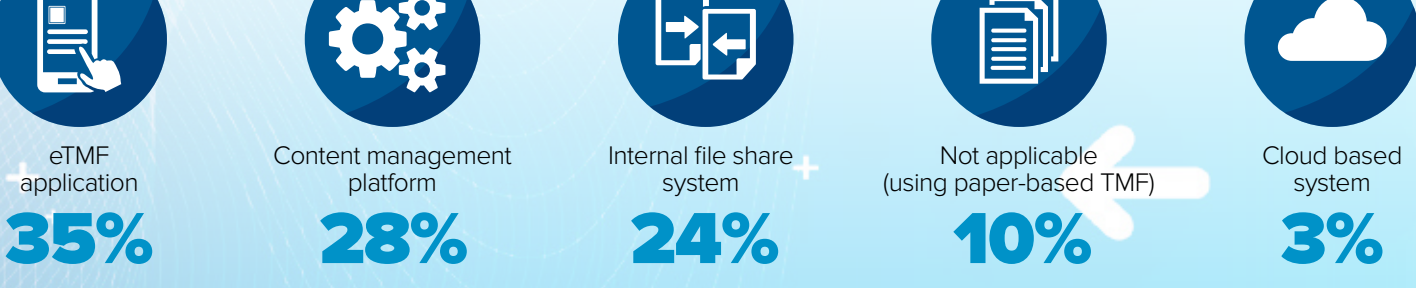
IN THE NEXT 12 MONTHS HOW MUCH ARE YOU LOOKING TO INCREASE INVESTMENT?



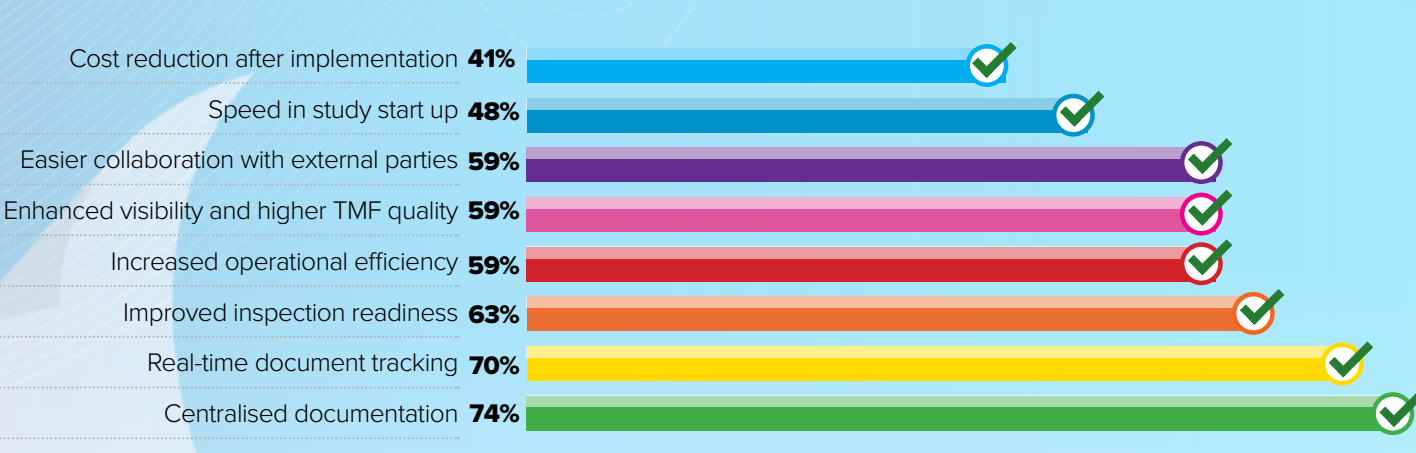

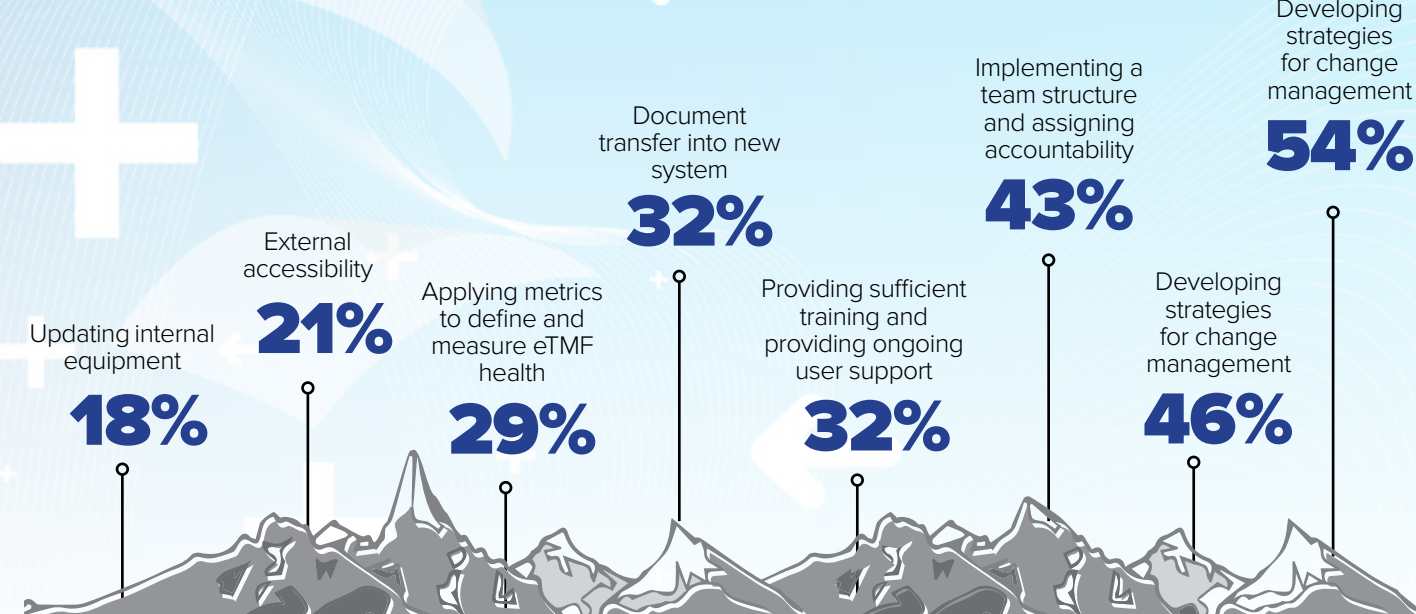
WHAT TYPE OF eTMF HAS YOUR TEAM USED MOST RECENTLY?



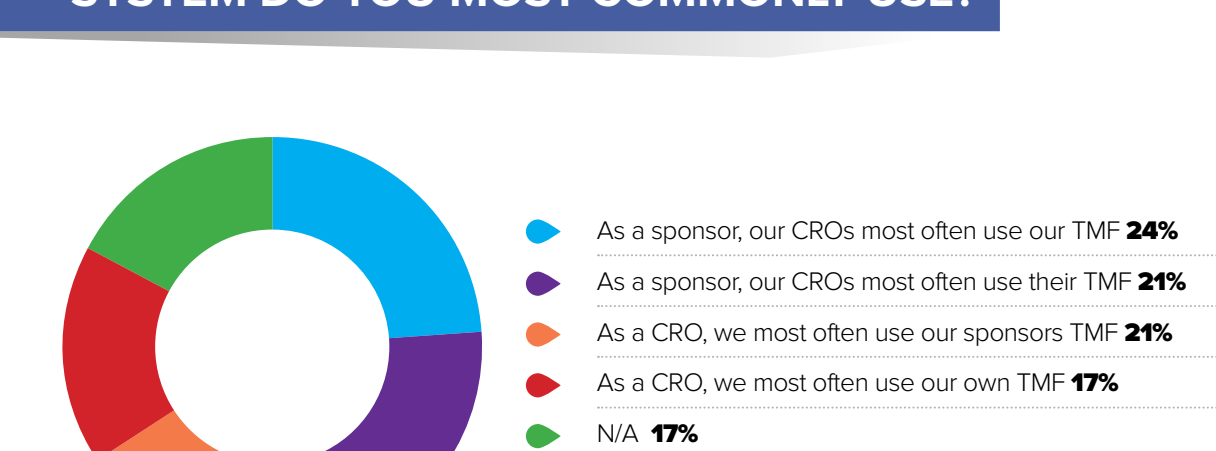
WHAT BENEFITS HAVE YOU SEEN TO DATE FROM THE USE OF AN eTMF?



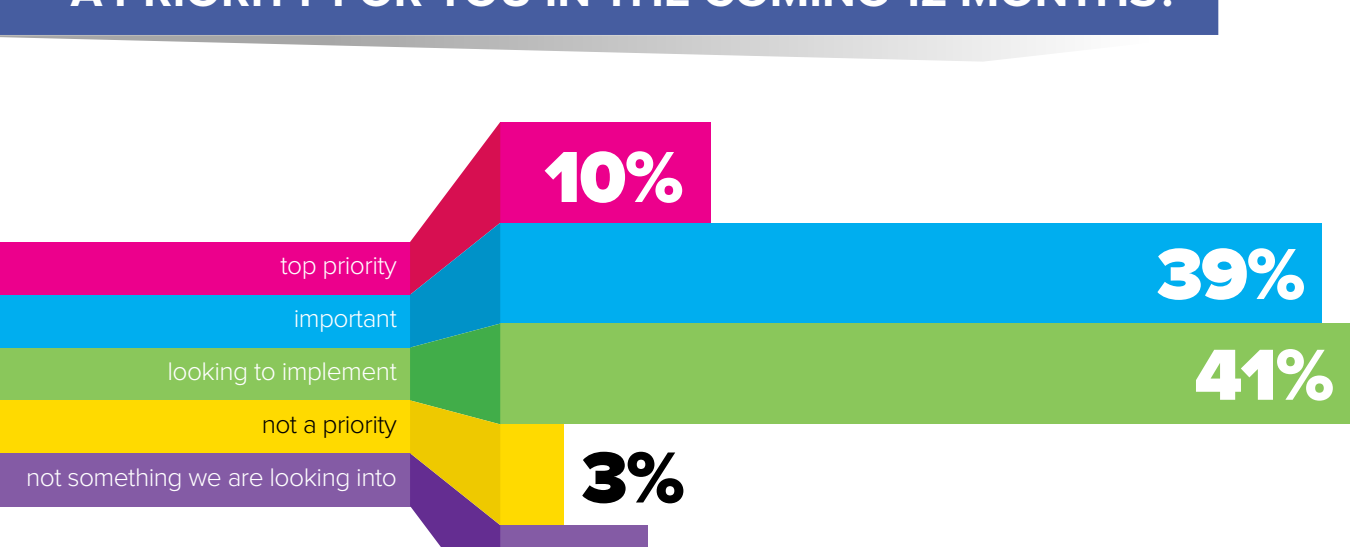
